

NOTIFICATION.

Dacca.—No. 5674For.—12th April 1943.—
Whereas the Board of Revenue, Bengal, as the Court of Wards in charge of the Estate of Srijukta Saraju Bala Debi, Srijukta Ananda Kumari Debi and Mr. Ram Narayan Roy Choudhury, Wards of Court, known as the Bhowal Wards Estate in the district of Dacca and the Manager of the said Estate as Attorney of Mr. Ramendra Narayan Roy Choudhury, a proprietor of the said Estate (in accordance with decree in title suit No. 38 of 1935 in the 1st Additional Judge's Court, Dacca), have represented in writing to the Collector of Dacca their desire that the lands described below, which form part of the Bhowal Protected Forest under notification No. 38For., dated the 12th January 1934, as amended by eratum No. 14177-For., dated the 17th July 1937, and notification No. 23694For., dated the 14th November 1938, should no longer be managed as protected forest;

Now, therefore, in exercise of the power conferred by section 38 of the India Forest Act, 1927 (XVI of 1927), the Governor is pleased to amend notification No. 38For., dated the 12th January 1934, as subsequently amended so as to exclude

the lands described below from the lands specified in the schedules to the said notifications:—
